## **Explaining the financial figures:**

On both the **European** and **North American** side, there was minimal fluctuation in the giving although the number of donors decreased while the amount of the donations increased.

The **Special Projects** is primarily related to the Council of 70 and the Circuit Riders Fund. Extra effort to increase the number of Council of 70 members ended due to the Grant from the EU and the need to spend the time on reaching the goals of the work plan.

The amount under **Subsidies** this year from the European Commission is for the operational expenses. Other subsidies are found in the Income Activities and the Internship Support.

**Staff Support**: These are gifts for freelance staff and volunteers, primarily for Cathy Faber.

**Internship Support**: This is **for seven** EVS-Interns, five from January till the end of August and two new EVS-ers from November 1 to December 31.

## **EXPENSES**

Internship Expenses: Besides the monthly expenses for these seven EVS interns, this also includes the coordination expenses for this project (Cathy Faber) in the amount of  $\leqslant$  4.500,-.

Mission Projects cover the activities and set-up expenses organized by the office in Kruiningen in Central Europe. It does not cover the activities organized regionally for the Bridgebuilders. This is primarily for the Czech Republic cluster.

**Development**: This category is about fundraising and is made up mostly of printing and copying expenses for newsletters, mailings and some specific travel expenses.

Personnel: Only salaried staff and volunteers are found under Personnel. Freelance staff and volunteers are distributed under the various project they were involved in. If we add all salaried, freelance and volunteer staff together, we have a figure of € 58984. Yvette (curriculum developer and trainer) falls under Training, Cathy (Intern coach and office) falls partly under Internship Expenses and partly under Office, Sam (finances) falls under Office, Rip (website) under Communication and the Czech volunteer staff (Bo, Lenka, Kamila) under Mission Projects.

**Communication** expenses cover the internet, website and telephone. They were up from the previous year mostly due to adding personnel costs for the website.
